

No. GP-32-MCG/1017/SFS-162/J.- In exercise of the powers conferred by sub-section (1) of section 20 read with section 4 of the Gujarat Professional Medical Educational Colleges or Institutions (Regulation of Admission and Fixation of Fees) Act, 2007 (Guj.3 of 2008) the Government of Gujarat hereby makes the following rules further to amend the Gujarat Professional Medical Educational Courses (Regulation of Admission in Undergraduate Courses) Rules, 2017, namely:-

1. These rules may be called the Gujarat Professional Medical Educational Courses (Regulation of Admission in Undergraduate Courses) (amendment) Rules, 2017.
2. In The Gujarat Professional Medical Educational Courses (Regulation of Admission in Undergraduate Courses) Rules, 2017, in rule 4, in sub-rule (6),-
  - (i) in clause (b), after the words "administrative reasons", the word "and" shall be inserted;
  - (ii) after clause (b), the following clause shall be added, namely:-
    - (c) "sons and daughters of defense personnel who are domicile of Gujarat State and presently serving outside the Gujarat State."
