No.GP- 06 -MCG-1019-111-J: In exercise of the powers conferred by sub-section (1) of Section 20 read with Section 4 of the Gujarat Professional Medical Educational Colleges or Institutions (Regulation of Admission and Fixation of Fees) Act, 2007 (Guj.3 of 2008) the Government of Gujarat, hereby makes the following rules further to amend the Gujarat Professional Post-Graduate Medical Education Courses (Regulation of Admission) Rules, 2018 namely:-

1. These rules may be called the Gujarat Professional Post-Graduate Educational Courses (Regulation of Admission) (Amendment) Rules, 2019.
2. In the Gujarat Professional Post-Graduate Medical Educational Courses (Regulation of Admission) Rules, 2018 (here in after referred as "the said rules") in rule 5,

(i) in clause (A), in sub-clause(2),

after item (c) the following item shall be inserted namely :-

"(d) Economically Weaker Section : 10%"

(ii) after item (d) so inserted for the existing Para and Explanation there under the following shall be substituted, namely;

"For allocation of seats (SC/ST/SEBC/OPEN/EWS and Disabled Persons), under different categories, a roster system as notified by the State Government shall be followed.

Explanation: - The reservation of the seats shall be for the candidates belonging to the Scheduled Castes, Scheduled Tribes, Socially and Educationally Backward Classes and Economically Weaker Sections recognised as such in the State of Gujarat and not for those who have migrated from other States".


3. In the said rules, for rule 7 the following rule shall be substituted, namely.
Reservation for Disabled Persons: Five percent of the available seats in each category in Government Colleges and Grant-in-aid colleges or Institutes shall be reserved, for disabled candidates of the respective categories laid down in the Rights of persons with Disabilities Act, 2016.

P.T.O.

The Certificate shall be obtained from the Medical Board constituted for this purpose by the State Government. The Certificate shall contain extent of disability and suitability of such candidate for undertaking the course.

4. In the said rules, in rule 10, in sub-rule (1),
(i) for item (vii) the following item shall be substituted namely,
“(vii) Caste Certificate/ Eligibility Certificate for a candidate belonging to scheduled Castes(SC), Scheduled Tribes(ST), Socially and Educationally Backward Classes (SEBC) and Economically Weaker(EWS) issued by the authority empowered by the Government in this behalf (for SC,ST,SEBC and EWS candidates)”;
(ii) For item (ix), the following shall be substituted, namely,
“(ix) Certificate of Disability issued and duly signed by the Medical Board Constituted or Medical Officer authorized for the purpose (for disabled candidates)”
5. In the said rules, in rule 11, for sub-rule (2) the following shall be substituted namely:-
“(2) Merit-list of In-service and disabled categories will be prepared separately.”
